

Improving People's Lives

ServeNow works with disadvantaged children, orphans and street children in centers located in a major slum in Kolkata, India, and one in Kathmandu Nepal. In India, a school from Kindergarten to Grade 4 is in operation; in Nepal, children are tutored, as well as taught life values through teaching, drama, music, crafts, games, and other activities. 851 children benefited from this center in India and 170 children received ongoing tutoring in Nepal.

Across India 3,181 children were also reached through various Sunday School and VBS programs. ServeNow also operated two summer camps for 179 children in Ukraine. During the school year in Ukraine, 12 students participated in meetings which addressed topics related to health, human trafficking, safety, freedom, and critical thinking skills to develop habits to protect them. Another 223 were provided training in media, sewing, English classes, online skill training, etc. in Ukraine. In Uganda, one multi-purpose hall with a kitchen and classroom block was completed to serve several hundred kids. Additionally, a storm damaged roof was repaired at a school. 81 children were also sponsored on an ongoing monthly basis in Uganda.

ServeNow operated several tailoring schools as well as cosmetology schools and bakery classes to train young women in a trade to avoid being drawn into trafficking. 24 women received vocational training and counseling in India. 15 students were trained in cosmetology, baking, and starting their own businesses in Ukraine. 640 women in Nepal went through a tailoring program or non-formal education classes. 56,150 women also received awareness training on social issues such as human trafficking, child labor laws etc.

Equipping the Church

At the core of ServeNow is assisting local congregations in remote areas and in slums. This includes providing churches with bibles, literature, and pastors and ministry leaders with training in a series of discipleship material over 7-10 years, so they can systematically instruct their congregations.

152,541 pieces of literature (mostly Basic Series Discipleship resources) were printed and distributed to pastors, leaders, and congregation members. 73,230 Basic Series discipleship booklets and other Scripture literature were distributed among churches in India and 3,287 leaders were trained through conferences. 13,500 Basic Series books were distributed to twelve major churches in Ukraine to go out to smaller branch churches. 44 pastors, with no other means of transportation, were provided bicycles to travel throughout Uganda to their churches.

Another 22 pastors in India were also provided bicycles. 7,941 Basic Series books were studied in Uganda among 355 churches with 12,000 more being printed. 500 leaders benefited from Leadership Training in Uganda. 16,870 pieces of material (Basic Series, Story of Jesus, bibles) were distributed in Nepal. 4,500 Ki-Swahili Basic Series books were printed in Kenya. 18,000 French Basic Series books were printed for over 600 churches throughout the Ivory Coast, Benin, and Togo. Most were distributed in this fiscal year through a couple of pastor conferences in each country where 335 pastors also received specific training. 3,000 Basic Series books were also printed in Burundi. 100 pastors received training representing 65 church partnerships. In Sri Lanka, 3,000 Basic Series books were printed, and two pastor conferences were provided. Another 500 Spanish books were sent to a church on the US Mexico border. Most of these pastors and leaders in these countries above do not have access to literature that helps them understand the foundational truths of Christian faith. 25 million Arabic speaking people were also reached through various social media channels with a new video series called The Road to Paradise in Arabic.

Outstretched Hands

ServeNow provides day medical camps, with national physicians and nurses, seeing approximately 100 patients a day. 1,487 patients were able to receive medical treatment and prayer at medical camps in India. Another 300 benefited from a medical clinic in Nepal. In areas where it gets freezing cold and children and elderly have no winter coverings, we provide winter clothing in remote villages and in slums. Mosquito nets are provided in areas where many of the recipients otherwise may become gravely ill from malaria. 2,767 people received winter clothing and blankets in India and Nepal. 600 mosquito nets were provided for children and families to protect from malaria during the worst monsoon season in Nepal. ServeNow was also able to provide food for people in desperate need at a Yazidi refugee camp in Iraq (300 families), 1,000 people at the US Mexico border waiting to enter legally, and 100 families in a refugee camp in Uganda from South Sudan. ServeNow also provides container loads of humanitarian aid such as medical equipment, ServeNow also provides container loads of humanitarian aid such as medical equipment, wheelchairs, clothing and furniture for under-equipped hospitals and disabled people. 113 disabled people received a wheelchair or crutches. 13 hospitals or organizations also received medical equipment, beds, furniture, clothes, etc. A second container was also shipped with more items for those in need. ServeNow gave over 6,500 Christmas gifts to adults and children from disadvantaged families both in the war-torn area of Ukraine, as well as other parts of the country, as a token of love.

Short term teams provide additional needed staffing for a variety of humanitarian and other ministry programs. It also allows individuals to have a life changing experience by spending two weeks in international settings, working alongside nationals in humanitarian projects. Team members may also assist national doctors and nurses in medical camps as well as providing free drinking water in areas where no water is available. Some other areas involve taking part in summer camps for orphans, physically challenged and refugee children. A couple teams were sent out this year to serve in this capacity.

Ministry Coordination

ServeNow maintains operational offices in several locations in India, Sweden, Nepal, and Ukraine. These offices coordinate the projects in each of their respective areas. ServeNow provides ministry, leadership, and project support for these offices as part of its program services. This support allows the national leaders to hire competent national staff, which thereby also supports the local community in these countries. In other countries we work with various partners, national leaders and partner organizations to carry out our mission.
